

Parkway Parade – Evening Parking Perk (“Promotion”)

Terms and Conditions

1. Evening Parking Perk

Till 28 February 2026

- 1.1. Shoppers are eligible to receive a \$2 parking coupon with a min. nett spend of \$30 at Parkway Parade from 6pm, within max. two (2) combined same-day receipts.
- 1.2. Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- 1.3. The time indicated on the same-day receipts must be from 6pm/18:00 onwards, to qualify for the redemption.
- 1.4. Redemption must be made on the same day as purchase at L2 Concierge Desk from 6pm – 8.30pm only and is limited to one (1) redemption per shopper per day, regardless of total amount spent on a first-come, first-served basis or while stocks last.
- 1.5. While parking coupon are issued at L2 Concierge Desk, Lendlease Plus Members are still required to clock their spends to earn Lendlease Plus\$ based on their qualified transaction(s) by
 - Presenting their Lendlease Plus Member QR code at Instant Earn participating stores during the point-of-sale to earn the Plus\$ instantly. Instant Earn participating stores can be identified by the 'Accepts Instant Plus\$ Earning' icon on the Lendlease Plus mobile app's respective store pages; or
 - Uploading receipts via the Lendlease Plus mobile app. The E-Voucher will be credited to member's in-app wallet upon approval of qualifying receipt(s) within one (1) working day.
- 1.6. The \$2 parking coupons awarded are valid for use at Parkway Parade's carpark on the same day of issuance only, and cannot be refunded, exchanged for other denominations, cash or vouchers.
- 1.7. Lost, damaged, defaced, stolen, expired and/or void parking coupons will not be replaced.
- 1.8. For Lendlease Plus Members with existing Park Plus\$ stored in the Lendlease Plus app wallet, please note that Park Plus\$ will not be available for use in conjunction with this parking coupon.
- 1.9. Only one (1) parking coupon can be utilised per exit. To utilise the parking coupon, please note the following:
 - Remove the cash card from vehicle's IU before reaching the exit gantry. Full parking amount will be deducted if the cash card is not removed upon reaching the exit gantry.
 - Insert parking coupon into the 'Scan Ticket' slot of the exit gantry.
 - For any excess parking charges after deduction of \$2 parking discount, please reinsert cash card into the vehicle's IU for payment.
 - Please ensure there is sufficient fund in the cash card before exiting.
- 1.10. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- 1.11. All redemptions are further subject to the General Terms and Conditions as set out below.

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Parkway Parade reserves the right to request for proof of age at any time.
- ii. For redemptions at the L2 Concierge Desk, original same-day receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.

- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilisation, points redemption, membership credits, gift cards, coupons, stored value cards spend and vouchers from Lendlease, retailers, or other external partners.
- v. All redeemed and/or utilised E-Vouchers are strictly non-refundable, non-exchangeable or non-transferable for physical vouchers, Lendlease Plus\$, cash or any other form.
- vi. A Member may redeem not more than S\$2,000 worth of Lendlease Plus\$ to Lendlease Physical Vouchers per day at the Concierge Desk.
- vii. For instalment payments and deposits, only nett amount paid on the same day of redemption is valid.
- viii. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
- ix. Receipts from purchase of Lendlease vouchers, retailer vouchers or membership, iTunes gift cards, top-up of pre-paid SIM cards, stored value cards spend, bill payments, online purchases, office tower tenants, Singapore Pools, insurance, financial or investment services, refundable deposit for services or products, trade-in of products, or other types of rebate, AXS/SAM payments, ATM or Cash Card transaction(s), Medical, Dental, Banks, Money Changers, Cars International, Classic Beaute, Eco Ring, My First Skool, Ma Kuang TCM and retailers located at Level 5 are not eligible for any redemptions.
- x. Receipt of purchases made at atrium fairs and pop-up stores by non-mall tenant are not accepted.
- xi. Notwithstanding the provisions herein, Parkway Parade Management reserves the absolute discretion to determine the eligibility of any person who is interested to participate in the Promotion. Such determination is final and conclusive, and Parkway Parade Management is not obliged to give any reason for disqualifying any person from participating in the Promotion.
- xii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- xiii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Parkway Parade or Prime Asset Holdings Limited, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Parkway Parade and Prime Asset Holdings Limited (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- xiv. By entering our premises, you consent that any images, audio (including voices) and video footages, interviews, and/or likeness taken may be used by Parkway Parade Management for publicity and/or marketing purposes.
- xv. Parkway Parade Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xvi. Parkway Parade Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
