## Terms & Conditions

### 1. PROSPERITY BONSAI SHAKE

23 January – 3 March 2026 (both dates inclusive)

- 1.1. Lendlease Plus Members are eligible to redeem one (1) game chance with a minimum nett spend of **S\$28** in a single receipt.
- 1.2. Receipts from Cold Storage and FairPrice Xtra require double spending for redemption.

connection with the Redeemed Products. All disputes about quality or performance of the Redeemed Products shall be resolved directly with the store that sold the Redeemed Products.

  - For any excess parking charges after deduction of S\$2 parking discount, please reinsert cash card into the vehicle's IU for payment.
  - Please ensure there is sufficient fund in the cash card before exiting.
